Dear Parent/Carer,

I am writing to inform you that all Year 10 students will have a one to one careers interview with the Education Development Trust Careers Advisor, Maria Hayford-Fynn, during the next academic year when in Year 11, in order to give students the opportunity to discuss the options available to them post-16.

The interview will allow students to discuss their future aspirations and goals, and explore with the Careers Advisor suitable routes after leaving Year 11, whether this is through attending Sixth Form to study A-levels, college for a vocational route, or an apprenticeship. After the meeting, students will receive a Careers Guidance Action Plan which will remind students of the detail discussed in the meeting and also suggest action points for them to research regarding their next steps.

Throughout the year there will be further careers advice, information and guidance with regards to post-16 education.
